NOTIFICATION

WHEREAS in supersession of G.O. first read above, orders have issued in the order second read above on effective and immediate measures need to be continued to prevent and contain the spread COVID-19 applicable through the State with effect from 25.3.2020 which came into force for a period of 21 days with effect from 25.3.2020.

WHEREAS based on the 2nd and 3rd addendum sent by the Government of India, Ministry of Home Affairs amendments were issued in the Government orders third and fourth read above respectively to the Notification issued in the order second read above.

WHEREAS the Principal Secretary/Commissioner of Revenue Administration in the letter sixth read above has stated that the Government of India, Ministry of Home Affairs in the letter fifth read above issued 4th Addendum to the guidelines and the addendum has been got reconciled with the Government orders second, third and fourth read above and sent the amendment proposal to the Notification issued in the Government order second cited read with Notification issued in the order third and fourth read above.

NOW THEREFORE the State Government of Tamil Nadu based on the proposal of Principal Secretary and Commissioner of Revenue Administration issues following amendment to the Notification issued in the order second read above read with Notification issued in the order third and fourth read above.

A. the sub-clause (m) and (n) in exception to clause 4 may be added.

(m) Shops of agriculture machinery, its spare parts (including its supply chain) and repairs to remain open.

(n) Shops for truck repairs on highways, preferably at fuel pumps.

B. the sub-clause (f) in exception to clause 5 may be added.

(f) Tea industry, including plantation with maximum of 50% workers.

Note : As specified in the lockdown measures, social distancing and proper hygiene practices must be ensured in each of the above activities as well as the activities permitted by earlier orders. It will be the responsibility of the head of the organization/establishment to ensure compliance of such norms. The district authorities will ensure strict enforcement.


